The processing of personal data is based on legislation.

## Personal data included in the register and special categories of personal data

Applicant's personal information

- Last name

#### Other personal information

• Name and health insurance number of the physician who performed the health examination

Information on the applicant's suitability for the duties, based on his or her health and a safety clearance, shall be recorded into the register.

Charger Act (423/2016) Sections 6 and 12.

### Regular sources of data

The data shall be provided by the charger's certificate applicant.

The Regional State Administrative Agency that grants a charger's certificate shall get a brief personal security clearance on the applicant before granting the certificate, unless the applicant presents the Regional State Administrative Agency with a legal security clearance document.

The police and healthcare professionals are obliged to notify the controller of any such matters, that have come to their attention and that could affect the validity of the charger's certificate.

Information on deceased people for the purpose of removal of data, by the OSH Division of the Regional State Administrative Agency for Western and Inland Finland, shall be provided annually by the Population Register Centre.

### Disclosure of information

The following information will be transferred electronically for the printing of the charger's certificate (Charger Decree (220/2000), Section 1):

- Certificate number
- Last name of the certificate holder
- First name(s) of the certificate holder
- Personal identity code of the certificate holder
- Certificate issue date
- Certificate's last date of validity
- Certificate category
- Postal address

Notwithstanding confidentiality provisions, the Regional State Administrative Agency may disclose data referred to in section 22 to other authorities as necessary for the performance of their duties, or to state authorities of EU Member States or countries that are part of the EEA for the granting of certificates and performance of supervisory duties. The information can be disclosed by means of a technical interface or otherwise electronically. (Charger Act (423/2016) Section 23). Information is disclosed for the purposes described in section 23 of the Charger Act to authorities, such as

- The National Police Board of Finland
- The Finnish Safety and Chemicals Agency

The data included in the register shall be disclosed in accordance with sections 13 and 16(3) of the Act on the Openness of Government Activities (621/1999).

### Transfer of data outside the EU or the EEA

The data shall not be transferred outside the EU or the EEA.

#### Personal data retention period

Data recorded in the register shall be stored for five years after the validity of the certificate.

(Charger Act (423/2016) Section 22).

### Security of the processing of personal information

Manual material shall be stored on locked premises with restricted access.

IT processed data shall be protected through user group and access rights management, technical protection of servers, physical protection of premises, access control, data communications protection and backup copying of data.

# Rights of the data subject

### **Right of inspection**

The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning him or her is being processed. The data subject shall have access to the personal data.

Any data subject who wants to inspect data concerning himself or herself shall submit to the OSH Division of the Regional State Administrative Agency for Western and Inland Finland a request signed by the data subject or similarly authenticated or submit a request in person to the controller.

### Right to demand data to be rectified

The data subject shall have the right to obtain from the controller without undue delay the rectification of inaccurate personal data concerning him or her. The data subject shall have the right to have incomplete personal data completed.

Any data subject who wants to rectify or complete data concerning himself or herself shall submit to the OSH Division of the Regional State Administrative Agency for Western and Inland Finland a request signed by the data subject or similarly authenticated or submit a request in person to the controller.

## Other rights related to the processing of personal data

The data subject shall have the right to lodge a complaint with the supervisory authority (Office of the Data Protection Ombudsman) if the data subject considers that the processing of personal data relating to him or her infringes the EU General Data Protection Regulation.
