

## Compliance with the obligation to check under the Act on the Contractor's Liability for enterprises registered abroad

Under the Contractor's Liability Act, when the contracting partner is a foreign enterprise, the enterprise shall provide the information corresponding to that referred to in section 1, by presenting an extract from a register or an equivalent certificate complying with the legislation of the country where the enterprise is domiciled, or in some other generally accepted way. The table below indicates as per section 5 which certificates or corresponding documents, considering the foreign legislation, may be regarded as corresponding and trustful certificates for the compliance with the contractor's obligation to check of enterprises registered in these countries.

If the foreign enterprise, when the contract is concluded, has a Business ID in Finland, the contractor shall provide the information required under section 5(1) and (3) from Finland and the enterprise's home country.
